José Ramón Bauzá

President of the Balearic Islands (2011 - 2015) and MEP (2019 - 2024)

José Ramón Bauza is a Spanish politician who has served in the past as President of the Balearic Islands (2011-2015), Senator in the Spanish Senate (2015-2019), and as a Member of the European Parliament (2019-2024). His political career is characterised by his advocacy for economic development, educational reform, and European integration. In the EP, he has been the chair of the Tourism Task Force, Coordinator of the Transport Committee, where, among others, he has been the rapporteur of the RefuelEuAviation file (SAF) regarding the Fit for Fifty-five package. Currently, José serves as Founder and Chairman of the Aviation and Tourism Forum, a global platform dedicated to fostering collaboration, innovation, and growth within these industries. Additionally, he serves as a Board Trustee at the World Law Foundation and as a member of the Executive Supervisory Board at the Aviation Event. He also has an academic and professional background in pharmacy, which he continues to utilise as a pharmacy owner in his hometown of Marratxi. José is a pharmacy graduate from the Complutense University of Madrid, while also attending various professional courses, including the Advanced Course in Management and Direction of the Pharmaceutical Industry by IE Business School, Public Leadership and Entrepreneurship Program by Deusto Business School, the Workshop in Global Leadership by Harvard Kennedy School, and Workshop on the Future of Government by University of Oxford.

He is currently Honorary Consul of South Korea in Malaga and Honorary Consul of Mexico in South Korea. Javier Cremades is the author of numerous legal monographs and several books of essays. He holds a doctorate in law from the University of Regensburg (Germany) and UNED (Spain). He received a doctorate Honoris Causa from the International University of Valencia, Spain, and a post-doctorate Honoris Causa from the University of Bologna, Italy. He is a full member of the Royal European Academy of Doctors.
