# **Dana Bachmann**

Head of Unit for Social Protection, Social Rights and Inclusion, DG for Employment, Social Affairs and Inclusion, European Commission

Dana-Carmen Bachmann is currently Head of Unit in the Directorate General Employment, Social Affairs and Inclusion at the European Commission, being responsible for the modernisation of social protection policies, including access and adequacy of pensions, long-term care and health. Prior to this, Dana was Head of Unit in DG EMPL and DG EAC and was responsible for Vocational Education and Training, Apprenticeships and Adult Learning. Before her work at the European Commission, Dana worked as a lawyer at the European Court of Human Rights. # **Jan Ceyssens**

Head of Capital Markets Union Unit, DG FISMA, European Commission

Andreas has a doctorate in law from the University of Hamburg on the topic of citizen requests and referendums in the Hamburg districts.
